Tournament Venue: Vaughan Athletic Center, 2121 W. Indian Trail, Aurora, IL 60505. The 33,000 sq ft. Field House has dark blue, non-slippery sports linoleum floor, uniform lighting and 40 ft high ceiling.

Equipment: 38 Butterfly Centerfold 25 and Europa 25 tables, Butterfly nets and white 40 mm 3-star balls will be used. 36 courts will be 19 ft wide by 38 ft long and 2 courts will be 23 x 46. All courts will be fully barriered.

Rules and Policies:

- Tournament management reserves the right to modify, combine, or cancel events, limit total participants or total entries by event. If event is cancelled the fees for this event will be refunded.
- ♦ All USATT regulations apply. Only USATT approved equipment will be used. Butterfly tables, barriers and 40 mm white 3-star balls will be used.
- USATT Dress Code applies. The main body of the shirts, shorts and skirts must be significantly different than the color of the ball (white). No
 white shirts, shorts and skirts allowed.
- Do NOT enter two events with the same starting time.
- All matches are best of 5 games to 11 points, except the Open Singles quarter final through final, Women Singles and Open Doubles finals which will be best of 7 games.
- Unrated players may enter any event. However they will NOT advance from any rated round robin events. They can only advance from the 'Open Singles', 'Open Doubles', 'Under 18/14 Youth' and '40 and Over' events.
- For event eligibility the ratings as of December 19th, 2013 will be used. For seeding purposes the most recent available ratings will be used.
- For 'Under 18/14 Youth' events the participant must be under 18/14 years old on the day of the tournament. For '40 and Over' event the participant must be 40 years old on December, 31, 2014.
- No prizes will be awarded for splits, defaults and no-shows. Default time is event start time.
- Players must register at the desk no later than 30 minutes before the starting time of their earliest event.
- ♦ Gym will be open for practice from 8:00 am. Pre-match warm-up will be limited to 2 minutes.
- Withdrawals up through midnight January 10th, 2014 will be eligible for full refunds. There will be no refunds after this date.
- Any image, photographic or otherwise, taken of the tournament play or within the official venue is essentially the property of Butterfly or FVTTC (Fox Valley Table Tennis Club). Entrants agree to allow their picture, voice and likeness to be reproduced in connection with Butterfly or FVTTC by way of any medium.

Directions:

Take I-88 until Orchard Rd exit. At the light turn left and go for 1 mile until intersection with Indian Trail. Turn left (east) and go for 0.4 miles. The Vaughan Athletic Center will the large building with glass front on your left. Parking is to the east of the building.
