- USATT Dress Code applies. The main body of the shirts, shorts and skirts must be significantly different than the color of the ball. No white shirts, shorts and skirts allowed.
- Do NOT enter two events with the same starting time.
- All matches are best 3 out of 5 games to 11 points.
- For eligibility purposes the ratings from June 29th, 2018 will be used.
- For seeding purposes the most recent available ratings will be used.
- No prizes will be awarded for splits, defaults and no-shows. Default time is event start time.
